#### VIP Migration to Google Cloud Platform (GCP)

As we announced in early July, VIP is migrating to GCP by early 2021. As part of the migration process, Symantec is providing a method for testing your migration readiness. This can be done **between November 1, 2020 and November 15, 2020**. Instructions for completing this test will be posted to the Testing your VIP environment KB article. The IP netblocks needed for connectivity to the GCP service are also now available here.

### Recent Symantec SiteMinder Developments

A new validation build of SiteMinder has been posted for you to download and test in your development environment. Capabilities that are available in the build include:

- Improved DevOps via support of the SiteMinder REST interface with the popular open source code generation tool, Swagger Codegen.
- OIDC improvements
  - Ability to restrict OIDC token generation by group membership
  - Greater flexibility for aggregating user attributes from heterogeneous user repositories via support for both the Identity\_Map function and Identity Mapping.
- SiteMinder Administrators can be enabled via user store group membership
- Support for the Policy Server and Access Gateway on Windows 2019 and RHEL 8

Access to this validation build is offered via the Symantec SiteMinder project at the Validate.Broadcom.com location. We look forward to your feedback!

Symantec Privileged Access Manager is now listed on National Information Assurance Partnership (NIAP) Product Compliant List (PCL)

This is an important milestone as US Government procurement process requirements includes adherence to CNSSP#11 (Committee on National Security Systems Policy), a binding national policy for evaluation processes applicable to Commercial-Off-The-Shelf (COTS) products such as Symantec Privileged Access Manager.
